1. Using Downtown Redevelopment Districts as a Local ED Tool (Sites)

Presenter: Rob McCarthy, Partner, Bricker & Eckler

Downtown redevelopment districts ("DRDs") are Ohio's newest local economic development tool. They are also one of its most flexible. Through a DRD, a municipality can generate revenue necessary to pay costs of downtown revitalization by diverting a portion of property tax revenue (similar to a TIF) or establishing downtown redevelopment charges (similar to an NCA). These funds can be used for infrastructure needs or, loans/grants, incubator/accelerator costs, and, in some cases, operating costs necessary for downtown revitalization. Join us as we discuss how communities in Ohio can utilize these new tools. Case studies and example scenarios will be presented to show how Downtown Redevelopment Districts could work given their own parameters.

Opportunity Zones are a new community development program established by Congress in the Tax Cuts and Jobs Act of 2017 to encourage long-term investments in low-income urban and rural communities nationwide. The Opportunity Zones program provides a tax incentive for investors to re-invest their gains into Opportunity Funds that are dedicated to investing into Opportunity Zones designated by a state Governor and certified by the US Treasury. Ohio has over 300 Opportunity Zones certified by the US Treasury and federal regulations regarding this program are currently under review. Learn what Opportunity Zones are, how new federal regulations will impact their operation and how to launch Opportunity Funds in your community through the Launching the Opportunity Zone panel. This panel will provide a national perspective from the leaders in Washington DC who proposed the Opportunity Zone idea, who are regulating the operation of the tax incentive and local community leaders planning to launch an Opportunity Zone Fund in Ohio.

Bringing the Power of Place to your Economic Development Decisions with GIS (Infrastructure)

Presenters: Dennis Tubbs, GISP - Assistant Director; Carissa Signore, GIS Technical Applications Administrator II; Bryan Herschel, Executive Assistant – Summit County

The goal of our project is to utilize GIS data to facilitate economic development within Summit County. Summit County Planning/GIS is uniquely situated to conduct land availability searches and provide data on sites available to businesses. Searches can target properties near logistics routes, utilities, identify land use and zoning restrictions, provide information on workforce availability and dynamics, and highlight neighborhood demographic information. We created the Development Data Hub as the vehicle for the assembly of this data. Our Hub makes it easier to visualize, query, analyze, and disseminate information to businesses. There are a number of business problems that we focused on addressing through our economic development project. First, we are able to approach our economic development partners with an application which is interactive and the main repository for all economic development data. The Hub has allowed us to reach across these silos to let all partners use the same data to make more collaborative decisions. Second, it provides a fast and efficient process for getting site information to businesses by allowing partners to have access to spatial information immediately. Finally, in economic development, all decisions had been reaction-based instead of proactive and predictive. With the use of Survey123 and the Hub, we are able to conduct business visitations and record data metrics which allows us to start creating data metrics which could pinpoint themes for business assistance.

An initiative evolving from Sandusky's strategic goal of establishing a higher education presence in its downtown corridor, and responding to the needs of a very specific industry sector, parties from the Cedar Fair Corporation and Bowling Green State University are working on an undergraduate degree program that will provide a pipeline of employees not only to the thirteen amusement parks comprising Cedar Fair's holding, but also to the industry as a whole, both domestically and internationally. This presentation will present a work-in-progress, with a completion goal of Fall 2020 for the first entering class. While much of the focus will be on the mission and vision of the partnership, as well as details of the program to the extent they can be publically disclosed, we will describe the challenges and opportunities we have encountered as BGSU and Cedar Fair solidify this very complex private/public partnership, each from our different perspectives – corporate, municipal, higher-education, and economic development.

DriveOhio is a single point of connection for the smart mobility industries (automotive, technology and data) to work with researchers and government officials on the next generation of advanced transportation technologies. It would accomplish this by acting as one-stop-shop for anyone looking to test or build smart mobility technologies in Ohio and will prepare the state for the next generation of transportation infrastructure. The deployment of this technology could save hundreds of lives and prevent thousands of serious injuries on our roadways.

2. The Capacity Readiness Scorecard: Actionable, Practical Tips for Moving the State of Ohio Forward (Infrastructure)

Presenters: Janet Ady, President and CEO & Mark Knickelbine, Marketing Project Manager – Ady Advantage

In this customized session, Janet Ady of Ady Advantage will share useful and practical advice for implementing and improving community economic development efforts around the State of Ohio. Communities will have the opportunity to participate beforehand in Ady Advantage's Capacity Readiness Scorecard Survey. The survey is a proprietary tool developed by Ady Advantage that catalogs major organizational and regional asset indicators, and identifies areas for improvement. Ady Advantage will analyze up to 25 responses from Ohio communities and will include key findings in its presentation in order to share the state's economic development capacity readiness in terms of Workforce, Infrastructure, Business Support Systems, Quality of Life, Business Climate, Financials, Organizations, ED Programs, and Processes.

3. Special Improvement Districts: From Sidewalks to Bus Passes to Solar Panels (Tools and Programs)

Presenter: Colin Kalvas, Attorney, Bricker & Eckler LLP

Special improvement districts, or SIDs, present a unique way to fund and co-fund development and re-development projects. By creating and partnering with a SID, municipal corporations and townships can create a revenue stream paid by the users most benefitted by development or re-development projects. This presentation will highlight several case studies in which municipal corporations are leveraging SIDs to fund and co-fund innovative projects, including the highly anticipated Columbus C-Pass program. A special subset of SIDs, sometimes called Energy SIDs or ESIDs, can also be used to finance energy efficiency and renewable energy projects to both public and private property through property assessed clean energy financing, or PACE. The latter portion of this presentation will describe how local governments are using PACE to attract re-investment and development in their communities. The presentation will include background on PACE fundamentals and case studies for further understanding. Learning

objectives include: understanding traditional SIDs and special assessments, recognizing opportunities to use SIDs, learning how to combine SID special assessments with other sources of revenue, understanding ESIDs and PACE special assessments, and recognizing opportunities to use ESIDs. Colin Kalvas is a public finance and economic development attorney with Bricker & Eckler LLP. He has extensive experience at the forefront of the developing PACE market in Ohio. He also serves as counsel to a number of SIDs participating in innovative co-funding projects, including the Capital Crossroads SID of Columbus and its C-Pass program.

To combat the opiate epidemic and the associated costs, both tangible and intangible to the city, we've had to change EVERYTHING about how the City of Middletown conducts business on a day to day basis. Opiate addiction impacts every portion of the city including economic development. Beyond the tangible direct costs, there are so many intangibles that the City deals with on a daily basis. What better, more productive uses could have been accomplished (opportunity costs) if that money had been spent in other ways? How does the epidemic and negative media coverage of drug overdoses impact our ability to recruit new companies? With 4.1% unemployment in Butler County, how does the epidemic affect our ability to field a competitive work force in the region? What intangible effect has the image of drug abuse had on recruiting people to live, work and play in Middletown? This panel will discuss one city's battle on opiate addiction and the results we've had so far in this struggle.

According to research from DCI, regional and city economic develop groups invested approximately 39% of their marketing budgets in 2017 towards digital marketing efforts.

As economic development organizations continue to invest in digital marketing, it is important to understand the "customer's" journey and how different digital channels can be used to generate and nurture leads. While digital marketing is still relatively new to the world of economic development, my organization, Team NEO, has been actively using digital channels for the past two years to generate project leads. Using multiple platforms, from drip e-mail campaigns, to paid search, paid social and search engine optimization, we have had success in uncovering new opportunities for our region. This presentation will walk attendees through the customer's journey, illustrating how digital marketing can be a useful tool for your economic development organization. 2. Accelerating Economic Growth by Harnessing New Technical Tools (Tools and Programs)

The new economy is impacting all locations and communities. In doing so it is raising the stakes for economic development practitioners by simultaneously making their task more difficult and more important than ever before. Knowledge-based jobs are the new economic accelerators. Economic practitioners must therefore build local capacity whilst also developing new ways to share market intelligence in order to capture new growth opportunities.

This can be a daunting but there are a range of cutting edge technical tools - online, software and data visualization techniques - which informed practitioners can harness to aid their communities adapt, thrive and survive in the rapidly changing world. These will be explored in this session using real work examples to inform, educate and upskill attendees. This session will be critical for all practitioners involved in capacity building and economic development at a local, national or international level.

- *Takeaway 1 - Economic development practitioners must ready communities for new economy-driven change and they can do this by using cutting-edge technical tools.*
- *Takeaway 2 - Technical tools used internally allow practitioners to better understand the change occurring around them and opportunities and challenges it presents.*

3. Predicting the Value of Tax Incentive Applications (Finance/Incentives)

Presenter: Dr. Michael Jones, Assistant Professor of Economics at the University of Cincinnati

This session will include the presentation of a predictive model of tax incentive values based on data from Ohio's Job Creation Tax Credit (JCTC) program. The administrators of the JCTC must consider employees, wages, investment, and other quantitative measures

when evaluating JCTC applications; but at the same time, they are given latitude to award incentives based on economically sound projects that strengthen the economy. While the model presented in this research is specific to these rules and standards, the findings are broadly applicable for any tax incentive. An understanding of these types of models will assist companies in applying for tax incentives from regional governments.

4. Decoding the Workforce Challenge (Workforce)

An employer-led session that every Economic Developer, Workforce Professional and Community Leader should attend whether they are new to the field or an experienced professional. This interactive session will provide individuals and communities with simple, effective tools to decode and diagnose the real "Workforce" problem and better prepare them to make appropriate recommendations to help employers resolve their workforce issues. Companies often state "We can't find enough people to work" - but where are they looking, who are they looking for, and why are they looking - why do they have openings at all? Is it a retiring but happy workforce, or rampant turnover due to sweatshop conditions, low pay or lack of development programs? And who is at the table within the company to fix the problem? Attendees will leave this session with tools (survey, knowledge) to decode employer workforce issues, better understand local labor challenges, recommend the right solutions, and develop stronger relationships with area employers.
