

## **Webinar: The Need for Connectivity, Steps for Access and Best Practices for Local Broadband Expansion**

Broadband plays an increasingly important role in economic development and is now considered a critical part of infrastructure. Yet, there remains a digital divide between communities—some with little to no connectivity and others with fast, reliable networks which they have been able to leverage into an economic development asset.

Considerations for network construction, such as rights-of-way issues and permitting processes, will also be explored.

## Professional Profile: David Corrado

David Corrado is a high performance, results-driven executive with a career demonstrating visionary leadership, expertise and distinguished performance in product strategy, fiscal management and operational management of national and international technology operations. Mr. Corrado is highly effective in directing organizations to meet their business objectives and implement business processes.

Mr. Corrado holds an Executive Master of Business Administration from Baldwin-Wallace College in addition to earning a Bachelor of Arts in chemistry from Baldwin-Wallace College, a Bachelor of Science in chemical engineering from Cornell University. Mr. Corrado is a graduate of IBM Sales School and is an IBM Certified Consultant along with qualifying for five national technical awards.

Mr. Corrado's background in operations, network operating systems, project design and management, and systems integration provides a strong base for his technology management expertise. As an IBM consultant, Mr. Corrado architected business process methodologies and taught project management to Fortune 100 companies.

Over the past 36 years, Mr. Corrado has guided professional service practices to profitability, built consulting practices in companies that were historically hardware distributors and designed automated workflow management systems that were recognized worldwide as a best practice tool. He has been instrumental in establishing the first telemedicine broadband network within Ohio and his program methodology for this project was recognized nationally by USAC, the administrative arm of the FCC. Mr. Corrado is involved in bringing advanced networking services to local government and healthcare institutions.

Most recently, Mr. Corrado has acted as the CEO of the Medina County Fiber Network (MCFN), a municipal high-speed fiber broadband network providing transport services for fourteen major telecommunications carriers.

In the past five years, Mr. Corrado has been instrumental in replacing and implementing a new fiber network backbone infrastructure, providing advanced redundancy and diversity technology that no other fiber network in Medina County possesses. This advanced backbone led to Mr. Corrado attracting fourteen network carriers to connecting with the MCFN, bringing new telecommunications services into Medina County. Mr. Corrado has increased monthly revenue 1,467% over the past five years, through negotiating short term and long-term contracts with commercial companies and large cellular providers.

Most recently, Mr. Corrado is spearheading a fiber to the home project, constructing a public-private partnership with a nationwide investment firm, concluding a three year worldwide search and negotiation project.

Lindsey Brannon is the Head of Finance for Neighborly and her responsibilities include fundraising, project finance, and overseeing capital plans for optimal returns. With over ten years of banking experience, Ms. Brannon works across multiple layers of the firm and is currently developing Neighborly's broadband group and the Neighborly Infrastructure Opportunity Fund.
